For what purpose we collect and use your personal data? <p>How you can revoke your consent to the processing of data, restrict its use or disclosure, including stop using your data for secondary purposes?</p>	<p>At any time, you may revoke the consent given to us for the processing of personal data and limit their use or disclosure, in order to stop making use of them. 	<p>description of the personal data on those seeking to exercise any right and any other item or document that facilitates the location of personal data and any other documents required by applicable law at the time of filing the application, as well as email which we will send our reply or phone to which we can contact you.</p> <p>Within a maximum period of 20 days from the date the request is received, we answer your request and inform you about the origin of it through an email to the address you have provided or, where applicable, we will a phone call to go to our home to receive the requested response. If the request is answered affirmatively or appropriate manner, the requested changes will be made within a maximum period of 15 working days. The charge may notify within the periods referred to in this paragraph the extension thereof, for once, for a period equal to the original.</p>
